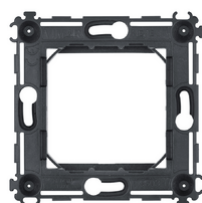

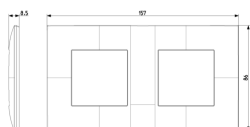


09602.1 - Frame 2M +claws

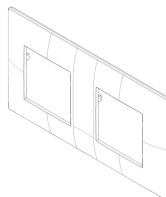
