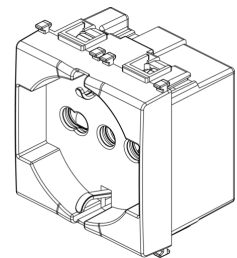

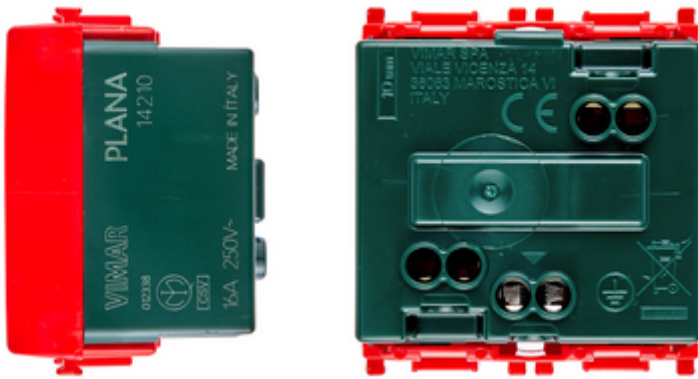
Backside view
