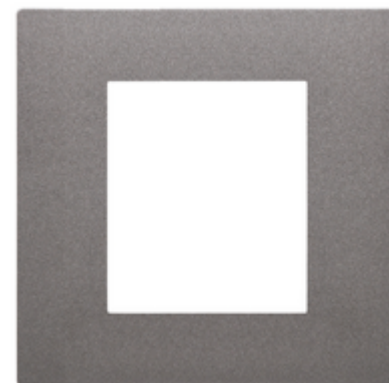

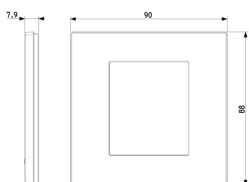


30603 - Frame 2M without screws 71mm

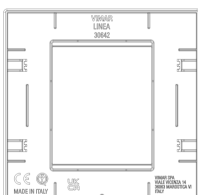

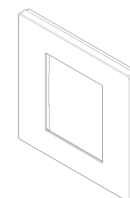

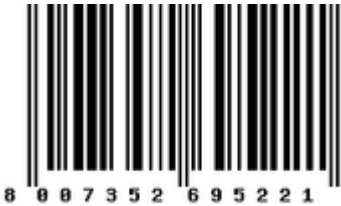
